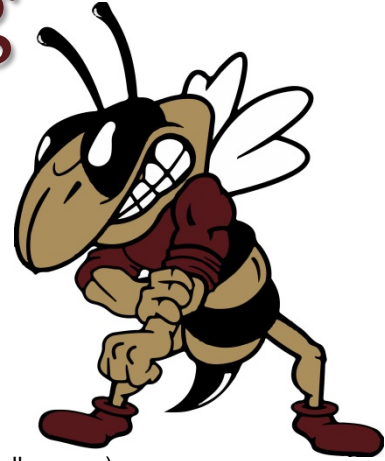


# Williamstown Jr. Wrestling Novice Tournament
